CANAAN, VERMONT – Mr. Paul E. Harvey, 78, of Canaan, Vermont, passed away peacefully at his home early Wednesday morning, December 27, 2006, surrounded by his loving family. Mr. Harvey was born December 17, 1928, in Coaticook, P.Q., Canada, son of the late Ligouri and Germaine (Girard) Harvey. Mr. Harvey was raised in Coaticook and married Jeanne E. De la Bruere in 1955.
